Ms. Stanley advised the County received four (4) bids from potential contractors for the Phase I Watermain Extension along Industrial Park Lane in the Lynches River Industrial Park. The following four (4) bids were received:

Dawn Development Company, Inc. \$447,250.00
Driggers Construction, LLC \$518,862.51
Carolina Civil, LLC \$595,070.00
Site Concepts, Inc. Not Responsive

Ms. Stanley advised it was the recommendation of Alliance Consulting Engineers and staff, that the bid be awarded to Dawn Development Company, Inc. in the amount of \$447,250.00, which is the lowest bid.

Vice-Chair Anderson made a motion to award the bid to Dawn Development Company, Inc. in the amount of \$447,250.00. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.
