c. Zoning Ordinance Amendment (Solar Projects) - 2nd Reading

Council Member Watson made a motion to pass 2nd Reading. Council Member Teal seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

STANDING COMMITTEE REPORTS

a. <u>Finance Committee – Committee Chair Curtis</u> <u>Additional Employee Request made by Kevin Thurman, Director, Voter Registration</u> and Elections

Vice-Chair Curtis advised that the Finance Committee met on January 22, 2020 regarding the request of Kevin Thurman, Director, Voter Registration and Elections for an additional employee. There was some discussion regarding this request.

Vice-Chair Curtis made a motion to provide funding for a temporary employee at a pay rate of \$12.00 per hour through December 31, 2020, with the understanding that these are non-recurring funds and that the Voter Registration and Elections Board understands and agrees these are non-recurring funds and only authorized through December 31, 2020, and that Lisa Gainey, Human Resource Director assist in finding the most qualified candidate. Staff is to prepare a Memorandum of Understanding between the County and the Board setting forth these terms. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ITEMS SUBMITTED BY STAFF

a. Bid Award - Meeting Street Paving Project - Eubanks

Mr. Eubanks advised that an Invitation for Bids (IFB) was issued for the Meeting Street Paving Project. Staff received the five following bids:

1)	Furr Grading & Paving, Inc.	\$ 87,000.00
2)	Industrial Paving, Inc.	\$106,495.00
3)	Evans Pavement Services	\$101,790.00
4)	Armstrong Construction	\$ 98,425.00
5)	Driggers Construction	\$132,960.70

It is staff's recommendation that the bid be awarded to Furr Grading & Paving, Inc. in the amount of \$87,000.00, which is the lowest bid.

Council Member Butler made a motion to award the bid to Furr Grading & Paving, Inc. in the amount of \$87,000.00. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. Bid Award - Belmont Drive Paving Project - Eubanks

Mr. Eubanks advised that an Invitation for Bids (IFB) was issued for the Belmont Drive Paving Project. Staff received the five following bids:

1)	Furr Grading & Paving, Inc.	\$ 69,999.00
2)	Industrial Paving, Inc.	\$ 77,005.00
3)	Evans Pavement Services	\$ 77,165.00
4)	Armstrong Construction	\$ 75,325.00
5)	Driggers Construction	\$ 96,999.40

It is staff's recommendation that the bid be awarded to Furr Grading & Paving, Inc. in the amount of \$69,999.00, which is the lowest bid.

Council Member Butler made a motion to award the bid to Furr Grading & Paving, Inc. in the amount of \$69,999.00. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

BOARD APPOINTMENTS

a. Library Board Appointment - Council Member Anderson

Council Member Anderson made a motion to appoint Paige Sartor to the Library Board as her representative for Council District 8. Council Member Butler seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

a. Pee Dee Regional EMS Board - Eubanks

Administrator Eubanks advised there was a need to appoint an individual to represent Chesterfield County on the Pee Dee Regional EMS Board, and that it is the recommendation of staff that Council appoint Chad Arant, Interim Emergency Preparedness Director, to serve on this board for a term of three years.

Vice-Chair Curtis made a motion to appoint Chad Arant to the Pee Dee Regional EMS Board for a three year term. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ADMINISTRATOR'S REPORT

Administrator Eubanks advised he had nothing at this time.

COUNCIL MEMBERS' COMMENTS
