CALL TO ORDER AND PRAYER

Chairman Johnson welcomed everyone and Council Member Ralph Watson opened the meeting with prayer.

ADOPTION OF AGENDA

Council Member Butler made a motion to adopt the October 6, 2021 regular meeting agenda. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

APPROVAL OF MINUTES

a. September 1, 2021 - Regular Meeting

Council Member Burns made a motion to approve the September 1, 2021 Regular Meeting Minutes. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

APPOINTMENTS

a. Don Strickland, Director, PDRTA - PDRTA Chesterfield County Transportation Update

Mr. Strickland appeared before Council to update them on transportation and to recognize Council Member Gerald L. Miller by presenting him with a plaque for his years of service on the PDRTA Board.

b. <u>Jane Toler and Stacey Short, Pee Dee Coalition against Domestic & Sexual Assault – Proclamation Declaring October as Domestic Violence Awareness Month.</u>

Ms. Toler and Ms. Short appeared before Council to brief Council and present them with some statistics regarding domestic violence in Chesterfield County.

Council Member Watson made a motion to proclaim October 2021 as Domestic Violence Awareness month. Council Member Miller seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

c. Andy Ingram, NETC - Letter of Support

Council Member Butler made a motion to approve a letter of support in support of satellite campuses in Chesterfield and McBee. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

Mr. Thurman appeared before Council to provide an update on the redistricting process.

ORDINANCE READINGS AND RESOLUTIONS

a. Emergency Ordinance - Tiny Homes

Council Member Conklin made a motion to adopt said Ordinance. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. <u>Tiny Homes and Tiny Home Developments Ordinance – 1st Reading, by title only</u>

Council Member Anderson made a motion to pass $\mathbf{1}^{\text{st}}$ Reading, *by title only*. Council Member Miller seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

c. Emergency Ordinance - Mobile Home Parks

Council Member Conklin made a motion to adopt said Ordinance. Council Member Watson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

d. Mobile Home Parks Ordinance - 1st Reading, by title only

Council Member Butler made a motion to pass 1st Reading, *by title only*. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

e. Community Development Program Community Enrichment Grant - Resolution

Council Member Burns made a motion to adopt said Resolution. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ITEMS SUBMITTED BY STAFF

a. Tower Inspection Bid Award - Stanley

Ms. Stanley advised Invitation for Bids (IFB) were issued for Tower Inspections. Staff received one bid from Pittsburg Tank & Tower Group and that it is the recommendation of staff that the bid be awarded to Pittsburg Tank & Tower Group.

Council Member Conklin made a motion to award the Tower Inspections bid to Pittsburg Tank & Tower Group. Council Member Watson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. Inmate Telephone Services Bid Award - Stanley

Ms. Stanley advised Invitation for Bids (IFB) were issued for Inmate Telephone Services. Staff received seven bids, a copy of which is attached. Ms. Stanley advised that it is the recommendation of Sheriff James Dixon that the bid be awarded to Combined Public Comm.

Council Member Miller made a motion to award the Inmate Telephone Services bid to Combined Public Comm. Council Member Butler seconded the motion. Voting in favor of the motion was unanimous. Motion passed.
