### **ITEMS SUBMITTED BY COUNCIL**

### a. Operation Green Light for Veterans - Council Member Anderson

Council Member Anderson advised the National Association of Counties (NACo) and the National Association of County Veteran Service Officers (NACVSO) have invited the nation's 3,069 counties, parishes, and boroughs to join Operation Green Light and show support for veterans by lighting our buildings green from November 7 to November 13. ### 13a. Bid Acceptance for CDBG Tanker Grant (Cash Rural Fire Department) - Hicks

Ms. Hicks advised that Invitation for Bids for a Tanker Truck for Cash Rural Fire Department was issued and two bids were received. The two bids received were as follows:

Fouts Brothers Fire Equipment in the amount of \$480,063.00

Williams Fire Apparatus Representing Southeast Apparatus in the amount of \$384,549.97

It is the recommendation of staff that the bid be awarded to Fouts Brothers Fire Equipment in the amount of \$480,063.00. A letter from Brandon C. Wilson, Fire Chief, Cash Rural Fire Department was presented to Council stating the reason for awarding the bid to Fouts Brothers Fire Equipment.

Council Member Conklin made a motion to award the bid to Fouts Brothers Fire Equipment in the amount of \$480,063.00. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

### **BOARD APPOINTMENTS**

### 16a. Pee Dee Regional Council of Governments - Chairman Johnson

Advised there was a need to appoint someone to the Pee Dee Regional Council of Governments Board to fill Council Member Ralph Watson's seat on the Board. He advised Council Member Anderson had advised she was interested in serving on this Board.

Council Member Butler made a motion to appoint Council Member Mary Anderson to the Pee Dee Regional Council of Governments Board. Council Member Rivers seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

#### **COUNCIL MEMBERS' COMMENTS**

**Council Member Anderson:** Jazz Festival will be the second weekend in October in Cheraw.

**Chairman Johnson:** Advised that Council Member Conklin had some concerns regarding lot sizes for building of homes and that he had advised Council Member Conklin that he would refer this matter to the Planning and Zoning Committee.

#### **EXECUTIVE SESSION**

- a. Chairman Johnson advised that pursuant to S.C. Code § 30-4-70(a)(1), Council needed to enter into executive session for the discussion of employment, appointment, compensation, promotion, demotion, discipline, or release of county employees.
- **b.** Pursuant to S.C. Code § 30-4-70(a)(2), Council needed to enter into executive session for the discussion of negotiations incident to proposed contractual arrangements, the receipt of legal advice where the legal advice relates to a pending, threatened, or potential claim or other

matters covered by the attorney-client privilege, regarding the following: fire protection and the issuance of building permits.

Council Member Burns made a motion to enter into executive session. Council Member Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

Council Member Rivers made a motion to exit executive session. Council Member Butler seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

### **REGULAR SESSION**

Chairman Johnson reported Council is back in regular session and that no action was taken and no motions were made in executive session other than to exit executive session.

After executive session, the Chair noted that the Administrator's current contract term expires at the end of calendar year 2023. Although the Administrator may continue to serve after that date, the Chair announced that the Personnel Committee was to explore the possibility of hiring a full time Assistant Administrator.
