CALL TO ORDER, PRAYER AND PLEDGE OF ALLEGIANCE

STANDING COMMITTEE REPORTS

<u>Finance Committee – Committee Chair Butler</u>

10.a.i. Poll Workers Pav

Finance Committee Chair Butler advised the Finance Committee met on August 10, 2022, at which time the members voted unanimously to recommend that poll workers receive an increase in pay in the amount of \$25.00 per election day.

Council Member Butler made a motion to give the poll workers an increase in pay in the amount of \$25.00 and that it be retroactive to include yesterday's Special Election. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

10a.ii. E-Scrap Fee

Finance Committee Chair Butler advised that the Finance Committee members voted unanimously to recommend that the County institute a charge of \$5.00 per television for disposal at the County Convenience Center.

10a.iii. ARPA Funds (Fire Departments)

Finance Committee Chair Butler advised the Finance Committee members voted unanimously to recommend that Council allocate ARPA funds to each volunteer fire department on millage or fee, in the amount of \$10,000.00, with the exception of Cheraw and Chesterfield which are under contract.

Travis Tucker, Fleet Management Director

Advised Council that he had been having problems finding a truck to purchase and that he had gotten a quote from Florence Truck Center in the amount of \$155,130.00. He advised that the other dealers he had spoken with said it would be two years or more before they could get a truck. Florence Truck Center advised him they could have a truck for him after the first of the year.

There was some discussion regarding this matter.

Council Member Miller made a motion to allow the Road Department to purchase a 2023 Mack PI64T Day Cab from Florence Truck Center in the amount of \$155,130.00. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

COUNCIL MEMBERS' COMMENTS

Council Member Rivers made a motion that the county no longer provide insurance coverage on the Old St. David's Episcopal Church and that the Church be given 30 days' notice,

in order that they may obtain insurance coverage on the Church. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.
