CALL TO ORDER AND PRAYER

Chairman Rhett Butler welcomed everyone and opened the meeting with prayer and led in the Pledge of Allegiance.

ADOPTION OF AGENDA

Chairman Butler advised there was a need to amend the order of the Agenda in that Agenda Items 9d, 9e and 9f would be taken up after Executive Session.

Council Member Foard made a motion to adopt the November 1, 2023 meeting agenda, with said amendment. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

APPROVAL OF MINUTES

a. October 4 2023 - Regular Meeting

Council Member Burns made a motion to approve the October 4, 2023 Regular Meeting Minutes. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

APPOINTMENTS

a. Senator Penry Gustafson

Appeared before Council and advised Delegation was looking for a full time magistrate and for a Voter Registration Board Member. She also gave an update on top items which have been accomplished in the Senate.

PUBLIC COMMENTS

Kip Kiser, Coroner

Appeared before Council and advised that the Coroner's Office and Sheriff are dealing with fentanyl within the County and would like to speak with Council at some point on moving forward.

SIGNING OF BONDS, PAYROLL, AND AUTHORIZATIONS

Bonds, payroll and authorizations were distributed to Council for approval by signatures.

PUBLIC HEARINGS

a. Ordinance Granting Temporary Easement to Town of Pageland - Public Hearing

Council Member Miller made a motion to open the Public Hearing. Council Member Curtis seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

There were no oral comments from the public made nor were any written comments received.

Council Member Miller made a motion to close the public hearing. Council Member Curtis seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ORDINANCE READINGS AND RESOLUTIONS

a. Ordinance Granting Temporary Easement to Town of Pageland – 3rd Reading

Council Member Miller made a motion to pass 3rd Reading. Council Member Foard seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. Reassessment Postponement Ordinance - 2nd Reading

Council Member Conklin made a motion to pass 2nd Reading. Vice-Chair Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

c. Project Furnace FILOT Ordinance - 2nd Reading

Council Member Burns made a motion to pass 2nd Reading. Vice-Chair Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

g. Standing Rules Ordinance - 1st Reading, by title only

Council Member Burns made a motion to pass $\mathbf{1}^{\text{st}}$ Reading, by title only. Vice-Chair Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

h. Family Court Awareness Month - Proclamation

Council Member Conklin made a motion to proclaim November as Family Court Awareness Month. Council Member Smallwood seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ITEMS SUBMITTED BY COUNCIL

a. Subdivisions/Mobile Home Parks - Council Member Foard

Council Member Foard brought attention to Council regarding county roads that go from dirt to pavement and county takes ownership. Council discussed the acceptance of subdivision roads and mobile home parks.

Council Member Foard made a motion to adopt an Emergency Ordinance Declaring a Temporary Moratorium on the Acceptance of Applications and Issuance of Permits for the Establishment of Mobile Home Parks and Subdivisions with the Unincorporated Areas of Chesterfield County. Council Member Conklin seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ITEMS SUBMITTED BY STAFF

a. Convenience Center Closing (Christmas Holiday) - Eubanks

Administrator Eubanks advised that staff would like to request that Council consider closing the Convenience Centers either Saturday, December 23rd or Tuesday, December 26th in observance of the Christmas holiday for the operators. There was discussion regarding this request.

Council Member Smallwood made a motion to allow Convenience Centers to close on Saturday, December 23rd in observance of Christmas holiday. Council Member Burns seconded the motion. Voting in favor of the motion were Council Members Smallwood, Burns, Curtis, Conklin and Miller. Voting in opposition of the motion were Council Member Foard and Vice-Chair Anderson. The motion passed 5-2.

Administrator Eubanks advised he had informed Codes not to issue any permits until 911 address is posted at home.

d. Shape Files – Eubanks

Administrator Eubanks advised that staff would like to request Council to allow staff to insert a GIS option on the county website for the public to export their parcels to build their own GIS layers. Currently, our county is one of the last counties to have this available online for the public.

Vice-Chair Anderson, District 8, made a motion to reappoint Michelle Stanley to the Grievance Committee. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

Chairman Butler made a motion to appoint Mike Hyduke to the Grievance Committee. Council Member Curtis seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. First Steps Partnership Board

With the departure of the previous County Library Director, the Chesterfield County Public Library System Board of Directors has recommended the Interim County Library Director Kathryn Cress for appointment to the First Steps Partnership Board. Ms. Kress previously served on this board from November, 2022 to August, 2023.

Vice-Chair Anderson made a motion to appoint Interim County Library Director Kathryn Cress to the First Steps Partnership Board. Council Member Smallwood seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

Vice-Chair Anderson:

- Advised that Council Member Burns did a great job representing the County and SCAC.
- Advised she would like for the County to support Operation Green Light for Veterans again this year. Council Member Burns stated she was also in favor of this too.
- Population change, the County dropped, need to stay on top of Friday Reports.

Council Member Foard:

 Advised he would like for Ms. Stanley and Mr. Eubanks to look at decreasing the cost of advertising.
