ITEMS SUBMITTED BY STAFF

a. Bid Award (Welcome to Chesterfield County Sign) - Stanley

Ms. Stanley advised a Request for Proposals was issued for a Welcome to Chesterfield County sign to be placed at Highway 1 entering from Kershaw County. Staff received the following four (4) proposals:

1)	Michael J. Jordan Construction	\$22,265.00
2)	Bullock General Contracting	\$27;300.00
3)	JP Smith, Inc.	\$28,320.00
4)	Rite Lite Signs	\$36,375.00

It was the recommendation of staff that the bid from Michael J. Jordan Construction in the amount of \$22,265.00, which is the lowest bid, be accepted.

b. Bid Award (Recycling) - Travis Tucker

Mr. Tucker appeared before Council concerning recycling. It is staff's recommendation that Council authorize the purchase of 10-30 yard containers from recycling funds through state contract from Waste Management.

NEW BUSINESS

a. <u>Town of Mt. Croghan Request for Funding (Hometown Fall Festival Celebration) –</u> Stanley

Ms. Stanley advised that in the past, municipalities would receive \$1,000 from the County to be used on their festivals.

Council Member Rivers made a motion to authorize the funding of \$1,000 to each municipality to be used on their festivals, this will be a non-reoccurring fund. Vice-Chair Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

a. Everbridge - Chad Arant, Emergency Management Director

Mr. Arant appeared before Council and presented information to Council concerning EverBridge, a public safety mass notification system, to inform Chesterfield County citizens of events. He advised there was a one year and three year contract option. The cost for this service was approved as part of the E-911 Technical Support budget.

Council Member Conklin made a motion to authorize the Administrator to enter into a three year contract with EverBridge. Vice-Chair Anderson seconded the motion. Voting in favor of the motion was unanimous. Motion passed.
