CALL TO ORDER

Vice-Chair Anderson welcomed everyone and opened the meeting with prayer and led in the Pledge of Allegiance.

OATH OF OFFICE

The Honorable Paul M. Burch administered the Oath of Office for Council Member Elect Brandon Price, District 1; Council Member Elect Eddie Kirkley, District 5; Council Member Hattie Burns, District 6 and Council Member Elect Bishop Johnnie McLendon, District 9.

ADOPTION OF AGENDA

Vice-Chair Anderson advised that the Agenda Items 10.h and 11.h would be struck from the agenda and taken up at a later date.

Council Member Foard made a motion to adopt the January 8, 2025 meeting agenda. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ELECTION OF CHAIR AND VICE-CHAIR

Vice-Chair Anderson advised at this time she would accept nominations from the floor for election to the position of Chair for the two (2) year term ending December 31, 2026.
