CALL TO ORDER

Council Chair Anderson welcomed everyone and Council Member McLendon opened the meeting with prayer and led in the Pledge of Allegiance.

OATH OF OFFICE

The Honorable John Melton administered the Oath of Office for Council Member Dr. Lawrence Brand, District 2.

ADOPTION OF AGENDA

C. Heath Ruffner, County Attorney advised there was a need to amend the agenda to add Agenda Item 19c, the sale of property located at 105 Green Street, Chesterfield and that exigent circumstances exist due to the contract for the sale of this property expiring on March 14, 2025.

Council Member McLendon made a motion to adopt the March 5, 2025 meeting agenda, with said amendment and finding of exigent circumstances. Vice-Chair Smallwood seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

APROVAL OF MINUTES

a. February 5, 2025 - Regular Council Meeting

Council Member Burns made a motion to approve the February 5, 2025 Regular Meeting Minutes. Council Member Kirkley seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

SIGNING OF BONDS, PAYROLL AND AUTHORIZATONS

Bonds, payroll and authorizations were distributed to Council for approval by signatures.

APPOINTMENTS

a. Andy Ingram, NETC

Appeared before Council to give Council an update on construction projects for NETC.

b. Irene Avery - Teals Mill Fire Dues

Appeared before Council regarding Teals Mill fire dues.

PUBLIC HEARINGS

a. Floodplain Management Ordinance Amendment - Public Hearing

Council Member Curtis made a motion to open the Public Hearing. Council Member Kirkley seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

There were no oral comments from the public made nor were any written comments received.

Council Member Curtis made a motion to close the public hearing. Council Member McLendon seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ORDINANCE READINGS AND RESOLUTIONS

a. Floodplain Management Ordinance Amendment – 3rd Reading

Council Member Curtis made a motion to pass 3rd Reading. Council Member McLendon seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

STANDING COMMITTEE REPORTS

a. Animal Services Committee - Committee Chair Foard

Committee Chair Foard advised the Committee met on February 5, 2025, to discuss getting the cat population under control at the Animal Shelter by implementing the catch, neuter and release program. He also advised that the paperwork had been filed with the DEA in order to get our license back for certain medication.

Council Member Foard made a motion to place a moratorium on cat intake, except for Animal Control and to waive adoption fees to get the cat population under control. Council Member Kirkley seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

ITEMS SUBMITTED BY COUNCIL

a. Tattoo Ordinance - Council Member Curtis

Council Member Curtis presented Council with information regarding tattoo facilities within the unincorporated areas of the County, and stated he felt people should be allowed to do whatever they would like with their own bodies, when it relates to tattoos. This item will be brought back to Council at the April meeting.

ITEMS SUBMITTED BY STAFF

a. Phase III - Lynches River Industrial Park Water - Stanley

Ms. Stanley advised because Phase II of the water project was completed under budget, combined with Utility Tax Credit funds received in December, based on the current estimate from Alliance Consulting Engineers, there should be sufficient funding to proceed with Phase III which will complete the water supply project to the park. In the event the cost exceeds the estimate, there are economic development funds available to cover any shortfall. Ms. Stanely requested that Council approve moving forward with Phase III.

Council Member Foard made a motion to approve moving forward with Phase III. Vice-Chair Smallwood seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

b. South Carolina Opioid Recovery Fund (SCORF) - Letter of Intent - Stanley

Ms. Stanley advised by Chesterfield County being a participating political subdivision of the South Carolina Opioid Recovery Fund (SCORF), we are eligible to submit a "letter of intent" to access an additional \$25,000 of funds to develop a comprehensive opioid remediation plan to address the opioid crisis in our community. These funds can be leveraged for any of the approved

abatement strategy headings such as training, treatment, prevention, diversion, coordination, etc. Ms. Stanley requested the Council approve submission of a Letter of Intent to access this additional funding.

Council Member Curtis made a motion to approve the submission of a Letter of Intent to access this additional funding of \$25,000. Council Member Burns seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

c. Rural Infrastructure Authority (RIA) Grant - Alligator Water - Stanley

Ms. Stanley advised that Alligator Rural Water & Sewer Company, Inc. intends to apply for an RIA grant in the amount of \$1,500,000 to fund a new well. If the grant is approved, the County would serve as a pass through for the funds. A match in the amount of \$319,981 will be required and will be paid entirely by Alligator.

Council Member Kirkley made a motion to approve application for this RIA Grant by Alligator Rural Water & Sewer Company, Inc. Council Member Curtis seconded the motion. Voting in favor of the motion was unanimous. Motion passed.

d. <u>Surplus Property – Sheriff's Department – Stanley</u>

Ms. Stanley advised that the Sheriff's Department has requested that Council declare the attached list of vehicles and equipment as surplus so that it may be removed from inventory.

Council Member Foard made a motion to declare the requested vehicles and equipment as surplus. Council Member McLendon seconded the motion. Voting in favor of the motion was unanimous. Motion passed.
